dersigned. *initial*

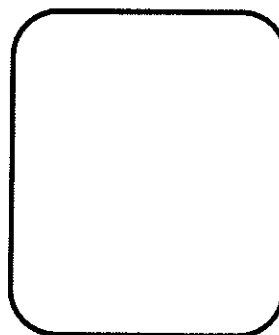
ASSURANCES: The undersigned has full power, authority, capacity, and right without
